

IO YEARS AFTER: A FRESHER IMPETUS TO PROFESSIONAL AND PERSONAL DEVELOPMENT

Last year was the 10th of UA&P as a university. It was a good occasion to assess the accomplishments of the University and, at the same time, give a fresh impetus to our efforts to fulfill UA&P's mission. Two of the areas where initiatives were strengthened were professional/ personal development and research & publications.

STRATEGIC PLANNING

The University focused its development efforts on the holistic and integral development of its faculty, staff, students, and the alumni, while continuing to implement the resolutions on the 10 key result areas (KRAs) identified in the 2002-2003 strategic planning exercises. The raison d'être of this year's undertakings is precisely to advance the strategic projects of the previous years.

Specifically, such developmental activities were done in recognition of the teachers' indispensable role in the life of the University so that they may contribute more effectively to the intellectual and moral vigor of the academic community, and of their responsibility to place UA&P among the prestigious academic institutions in the Asia Pacific region; of the administrative staff's endeavor to work with good will, competence, and team spirit in an atmosphere of freedom; and of the need to graduate students with an authentic UA&P brand by means of innovative forms of learning and Christian formation and to contribute to a better balance between the cost and quality of education.

To hone the teachers' pedagogical skills, the University established the Center for Teaching and Learning (CTL). This academic service unit will hold seminars and short courses on teaching, make Fellows available to coach teachers oneon-one and to give advice on pedagogy, and make materials on teaching in print or video available. Fellows have been identified and a seminar workshop for faculty on Elements of Teaching Practice has been delivered.

The University has also firmly laid down several faculty development programs in accordance with the strategic plans. These include the Three-Year Formation Program and the Corporate Culture Series. Other development goals will be mentioned in specific sections of this report.

For next year, organizational development will be pursued through, among others, strengthening of governance by completing the process of devolving decision rights to the OpComs and putting in place a three-year timetable for providing OpComs for each school. Program offerings will be subjected to a three-part cycle of review, beginning with the programs scheduled for accreditation or recognition visits. Concrete steps will also be taken to incorporate wherever possible in the courses the Christian dimension, liberal arts skills and civic education. For the administrative staff, the approved program for professionalizing the administrative support functions will be implemented. The goals are improved systems of information and delivery, data capture and transcription, and staff evaluation and counseling.

For the next five years, the strategic plans are aimed at achieving the University's objectives by adopting advanced research and teaching techniques; by acquiring and retaining high standards of academic and non-academic staff competencies; by strengthening cooperation among its employees, students, contractors, the community, and other external partners; and by attaining a level of economic self-sufficiency that will establish itself as a

center of academic excellence that admits well-qualified students from all sectors of society.

UA&P endeavors in the next years to achieve major goals such as strengthening the organizational structure for a more effective governance at the school and overall. university levels and setting up new programs such as Civic Education Program and MA/PhD in Philippine Studies. The University likewise aims to professionalize and upgrade research activities and strengthen its continuing education programs as well as current and international educational partnerships. It also sees that the information and computer technology infrastructure needs to be aligned to the University's vision; it will therefore work toward developing automated systems that will give the University a powerful information data base that harnesses data-source interactivity and proves meaningful metrics to improve overall efficiencies. In accord with its belief that the University should act as a positive agent of change in service to society, it sets its sight on setting up in every school, community outreach programs in the Pasig-Mandaluyong-San Juan areas.

INITIATIVES IN FASHION AND MEDIA

The University is planning several activities aimed at teaching the importance of a fashion and culture that are cognizant of the dignity of the person. A student conference on Youth, fashion and Culture will be held next year, with participants coming from UA&P and other schools in the National Capital Region. There are also plans to start a short course on fashion journalism and to hold workshops on social responsibility in the fashion world.




A FRESHER IMPETUS TO PROFESSIONAL AND PERSONAL DEVELOPMENT The First Integrated Marketing Communication Effectiveness Awards was held last July, with 98 nominees from advertisers and advertising agencies. The IMCEA recognized 19 of them who have been adjudged to have both effective and values-oriented marketing communications campaigns. There are also initial steps being taken to establish the Asian IMCEA to recognize marketing communications campaigns of advertisers and advertising agencies throughout Asia.

RESEARCH AND PUBLICATIONS

As an initial effort to professionalize research activities, the first issue of the new version of *Synergeia*—the faculty journal of UA&P—came out last school year. It featured articles that exemplify the multidisciplinary approach, which is the distinctive feature of the journal and is a hallmark of the education imparted in the threeyear undergraduate education at the University. Each







author straddles at least two disciplines in treating his or her research topic.

We also produced the first issue of the UA&P Catalog of Research and Publications, which shows the development and expansion of the research horizon of the University community. Its aim is to let the public know about researches undertaken by the faculty, their consultancy and technical advisory work, publications, and papers done in School Year

2004-2005.

In accordance with the University's objective of supporting publications, UA&P launched two books during the school year. The first is *Being Is Person: Personalism* and Human Transcendence in Socio-Economic and Political Philosophy by Fr. Joseph de Torre. The book tackles one key aspect of Karol Wojtyla's philosophical thought— Personalism—which is a view of man that highlights his uniqueness, unrepeatability, and openness to infinity. The other one is Rizal: Through a Glass Darkly by Fr. Javier de Pedro. This book attempts a spiritual biography of Jose Rizal: from the piety of his early youth, through his rejection of the divinity of Jesus Christ in early manhood, to his return to the sacraments a few hours before his execution.



STUDENT POPULATION

The student population in SY 2005-2006 was 2168 (compared to 2377 in the previous year). The total freshmen intake was 458, and the graduate programs had a total of 654 students (this includes all 4th-year students). The University's faculty-student ratio now stands at 1 full-time faculty member to 14 students.

459 students graduated at the end of SY 2005-2006, which is 1% fewer than in the previous year. 126 of them finished with graduate degrees, and 333, with bachelor's degrees.

There were 126 scholars last school year. For student scholarships, the University allotted P14.6 million.

STUDENT AFFAIRS

The Office of Student Affairs (OSA) continued its pursuit of whole-person formation as it staged its staple of activities last year, which collectively appealed to various interestsartistic, social, and athletic.

The Kultura Desk of OSA featured budding student photographers, poets, and instrumentalists, through its Young Artists Series. Its choir, the UA&P Chorale, swept the first prizes in the international choral competition in Preveza. Greece, winning over 12 outstanding groups from different countries. Then it staged five performances, beginning with a CD launch and capped by its annual Valentine concert. In between, the chorale exalted the community with season-based performances and glimpses of its winning pieces in Greece. The Desk also delivered its tradition of excellent theatrical performances with two plays, a theater of the absurd staging of Eugene Ionesco's "The Lesson" and Shakespeare's situational comedy classic "Comedy of Errors." The offerings were meant to inspire reflections on the complexities of instruction and the disastrous, albeit humorous, consequences of mistaken identities.

SportsDev continued its mission of promoting physical wellness through its Sports Day activities and its stable of varsity teams. The Desk maintained 12 teams last year, and won in more than one-third of the competitions they joined. Its Sports Day was a mix of activities that appealed to a range of skills and athletic interests, bringing together the UA&P community in a day of active camaraderie-building.

ACADEMIC OPERATIONS

Faculty Formation Program

Starting school year 2004-2005, all newly hired teachers with probationary status, whether for graduate or undergraduate programs, are expected to course the Three-

Year Formation Program prior to receiving permanent status. All permanent teachers who have not gone through courses identical or similar to the components of the Three-Year Formation Program are expected to take the courses they have not yet taken within the next 10 years. Completing this Formation Program, aside from the Continuing Formation Program that will begin in the near future, will be a condition for promotion.

The seminar for teachers on the first year of probation introduces teachers to the Credo, Mission Statement, and Statement of Principles. For teachers on the second year of probation, the seminar includes topics such as academic freedom, censorship, the Church, UA&P and political issues, and moral issues (divorce, abortion, contraception, euthanasia, homosexuality, Marxism, and religions other than Catholicism). The seminar for teachers on the third year of probation is the Course on Catholic Doctrine based on the

Catechism of the Catholic Church. Other formative activities for faculty members are the Corporate Culture Lectures and the workshop series for department chairs and senior faculty members. The topics in the corporate culture lectures included attitude of UA&P students towards religion, religion and politics, the population myth, teenage culture, traditionalism and modernism. The workshop series for department chairs and senior faculty members included topics on leadership, living the Christian perspective, curriculum planning and implementation, and budgeting and fiscal management. Activities were also

conducted to help faculty

members be more effective in their task of guiding students in their academic and personal formation through the UA&P mentoring system. The mentors were given monthly talks on the university corporate culture. The University also published and distributed the Guidebook for Mentors and the MA in Education with Specialization in Child Guidebook for Students on the mentoring system.

Faculty and Staff Grants There was a decline in the budget for and usage of faculty development grants last year. The University is resolved to push these grants in the coming year while taking into account the constraints from the decrease in tuition revenue. We continued to deload the teaching units of faculty who are pursuing master's or doctoral degrees. Three obtained their PhD degrees and one acquired a master's degree.

Science Stream Curriculum As the Institute of Information Technology Studies continues to fulfill its commitment to keep up with what the world demands from elite IT professionals, it began offering the Bachelor of Science in Information Technology (BSIT) on Science Stream Program at the start of academic year 2005-2006. The Science and Mathematics departments of the College of Arts and Sciences spearheaded the design of the Science Stream curriculum with which the IT curriculum was integrated.

As differentiated from the other programs of the University, which are based on the Humanities Curriculum, the BSIT on Science Stream program offers specialization subjects in the first year in the University instead of at the end of the second year. This new version of BSIT also differs from the old BSIT on the Humanities Curriculum in the following aspects: There are more science and mathematics units and fewer humanities courses. The total required units are fewer. · Summer classes are not required. The pilot class consisted of some 30 freshmen from different schools in the Philippines. Inclusion in the pilot

Development and Education Last school year, the School of Education started to offer a new program for teachers and other professionals

members by senior teachers. This move is in accordance with the University's mission to promote the integral development of all members of the University community.

program was by invitation to those who indicated their intention to pursue a career in IT. A few sophomore students in the Humanities program also opted to join the freshmen batch of IT students in the Science Stream program.

interested in pursuing graduate studies and specializing in early childhood education. The program leads to the degree of Master of Arts in Education major in Child Development and Education (MAE-CDE). Students in the program must earn 42 units to be eligible for graduation.

The MAE-CDE curriculum for practitioners intertwines four areas of learning: foundational subjects, psychology and counseling, specialization subjects and research. It is designed primarily for professionals who plan to develop higher competencies in early childhood education.

Last school year, 11 students enrolled in the program.

ADMINISTRATIVE OPERATIONS

Professionalization of the Administrative Units

The University launched last school year, the activities which form part of the integral plan of formation. The first two sessions of the Corporate Culture Series for Administrative Staff were conducted. Attendance in these sessions had been good (85% of administrative employees). Other training courses developed were the Business Communication Course and the improved employee orientation module crafted to introduce the staff to different aspects of the culture/spirit of the University, organizational structure, the academic programs, employee benefits, the code of conduct, and their obligations as employees.

The Corporate Wellness Program was partially launched during the Annual Physical Exam for employees. Diagnostic tests, which produced the baseline data for the program, were done. However, a fitness program for UA&P employees still has to be developed with the PE Department, based on the data from the diagnostics.

The results of the evaluation of these activities have so far been notable.

In terms of benefits, the University has worked toward improving the delivery of some benefits through the change in health-service provider as well as dental service-provider. As a result, our faculty and staff have better access to benefits with the increased number of accredited hospitals, clinics, and health providers. The change in service providers for health benefits has also given the University more valuefor-money.

Streamlined procedures and the development of improved systems in timekeeping, records and contracts administration and in recruitment and selection have brought welcome changes. Improvements in the timekeeping

hardware and software and in the timekeeping procedures have resulted in efficient monitoring of attendance and more efficient processing of the payroll. Improvements in the employee requisition procedures and greater focus on "sourcing and promoting from within" led to some improvement in the processing time for filling in of vacancies. There has been greater compliance among units with policies and approved procedures in employee hiring area due to closer monitoring of manpower needs and improved coordination with requisitioning units.

Intensified efforts in the updating of personnel files during the PACU-COA have resulted in the completion of 90% of the 201 files (mostly the files of the part-time faculty members remain incomplete).

HRM has completed the draft of the new Code of Conduct for Employees, which will replace the current Code of Discipline. In consultation with administrators and employees who have a good understanding of the University's culture, HRM made the Code more positive, highlighting the behavior expected of employees more than the offenses. The interventions are also made more formative than punitive. The Code is currently being reviewed for approval by the Management Committee.

The Management Information Systems (MIS) Office, on the other hand, still managed to deliver a good number of new systems and, at the same time, extend support for existing systems. Last year also saw the implementation of the new financial system replacing the 7-year old ERIC GL System. With the new system, MIS and the Accounting and Finance Unit are well poised to empower management, program directors, and unit heads with online information regarding their respective operations.

MIS also implemented a new timekeeping system for the Human Resource Management office and a reliable and accurate sales monitoring system for the canteen. On the enterprise level, MIS successfully upgraded our corporate mail system to the latest version of Exchange Server hosted on a newer and faster machine, and installed a robust content filtering system to block inappropriate content from the Internet.

Marketing the University

The Admissions Office carried out the marketing plan to campaign vigorously to as many high schools as possible. More high schools were visited and information about UA&P was disseminated to more schools compared to the last vear.

This year saw the full implementation of the "It's About You" campaign, which was launched during School Year 2004-2005. The new brochures and application kits, including the refurbished UA&P website, were all part of the execution for the said campaign. The School of Economics, the School of Management, the Institute of I.T. Studies, and the Humanities Program also launched their new audio-visual presentations in order to help in the marketing effort.

The Corporate Communications Office fulfilled its mission of informing the campus community and the public about the University, its concerns, activities and programs as an educational institution of higher learning by issuing the online This Week at UA&P, by producing university publications such as *Universitas* (the university newsletter) and the Annual Report, and by holding press conferences for the media, including the major newspapers and broadcast companies. The Universitas came out at a more frequent interval-quarterly-to keep its readers more updated. Twelve press conferences featuring the studies of UA&P experts took place during the school year. The topics included analysis regarding the economy (bright spots such as business process outsourcing and health tourism), tapping the overseas Filipino workers as a market, the effects of proposed tax measures, trends in the food and agriculture economic sectors, and the viability of a parliamentary system. The conferences were featured in television news programs and the major broadsheets.

EXTENSION ACTIVITIES

To sustain the high level of the University's social awareness in accordance with strategic plans, the Office

for People Development became the Center for Social Responsibility (CSR) last school year. CSR promotes sustainable development and corporate responsibility by way of extension work within and outside the University. It administers extension activities such as the following programs.

National Service Training Program

The National Service Training Program is the venue through which the UA&P faculty and students and partner institutions share their time and effort in undertaking various development activities. It gives emphasis on civic

consciousness and volunteerism. In School Year 2005-06, the activities included tutorials (on reading, mathematics, science, and English), sports clinics, feeding and medical missions, and community building (for instance, building school, dormitory and chapel; painting houses, and baking bread for a bakery). In addition, a series of CHED-led lectures were given to UA&P students. The modules covered good citizenship values, which included topics such as *maka-bayan*,



maka-tao, maka-kalikasan, and *maka-Diyos.* The lectures were aimed at raising socio-civic awareness among the students through interactive discussions.

I Am S.T.R.O.N.G. Project with Philip Morris

The school year was characterized by a variety of interventions. The first was the national administrators congress of the National Association of Public Secondary School Heads, Inc. (NAPSSHI), the PASSA federated organization made up entirely of public high school

administrators. Decision-making-seminar runs took place in five venues: Puerto Princesa City; Davao City and Cagayan de Oro City, each back-to-back with family conferences; the town of Infanta, Quezon; and Batanes. A set of new ventures in disseminating the I Am S.T.R.O.N.G. ideals was also developed this year.

Leadership and strategic planning seminar-workshops were conducted for college student leaders in the Lyceum of Batangas and the Columban College of Olongapo. Likewise, I Am S.T.R.O.N.G. triads gave presentations on moral education to two groups of educators: administrators under the aegis of Phoenix Publishing Co., and teachers under the Reading Association of the Philippines. Keynote addresses on moral leadership were likewise given in two national conferences of student leaders, organized respectively by the Private Secondary School Administrators of the Philippines (PRISSAAP) and the Young Men's Christian Association (YMCA). All interventions vielded an audience of some 1,500 students, 3,000 administrators and teachers and 1,000 parents.

The I Am S.T.R.O.N.G Project will be strengthened through research and conferences. In line with this effort, two representatives of the University attended the First International Congress on Relationships and Sexual Education held in Mexico City on May 19-21, 2006. The congress aimed to promote to educators an awareness of the importance of offering young people a deeper and more complete formation of their emotions and feelings. There may be plans to conduct the second congress here in the Philippines.

Extension programs with the British Embassy


In conjunction with the British Embassy, the Center for

Social Responsibility delivered a conference/ workshop on Corporate Social Responsibility (CSR) Strategies to create Business and Social Value for Small and Medium Enterprises (SMEs). The conference/ workshop was aimed at raising the awareness on CSR strategies to ensure profitability



and maximize the impact of SMEs on social development,

particularly in reducing poverty and creating partnerships at the local or regional level. It was delivered in three key cities-Angeles City, Iloilo City and Davao City-in cooperation with the various local chambers of commerce and business clubs.



Barangay San Joaquin Community Outreach

The social development program for UA&P's adopted Barangay San Joaquin continued to deal with education, health, and sports services. The program encouraged volunteerism from students, faculty, and staff through the different organized projects. All projects were properly coordinated with the local unit and schools in collaboration with teachers, social and health workers.

The Filipino Department conducted Teacher Training Program every other Wednesday for San Joaquin-Kalawaan High School. The program design was based on an assessment dialogue that the department conducted with the teachers. A book drive was started during the Freshmen Orientation Week, in cooperation with the civAsia desk of the Office of Student Affairs, for the benefit of a public library in San Joaquin. The different varsity teams were encouraged to participate in this outreach program by teaching the young volunteers of San Joaquin different sports. There were dance, volleyball, basketball and physical education for six consecutive Saturdays with a culminating activity on the 7th day to showcase what the children had learned.

Extension Activities of CAS Foculty

The Departments of History, Filipino, English, Arts, and Mathematics took time during the summer term to organize workshops for public high school teachers from several schools in Metro Manila. Through these workshops, the faculty members shared their extensive knowledge and skills with their colleagues in the public school sector. A total of 200 public school teachers attended the workshops.

Civitas Asia Student Conference Series CivAsia Student Conference Series for the schoolyear carried the theme "Ending Poverty: The Role of the Family, the University, and the Business Community." The theme was brought to Batangas for its Luzon run and to Iloilo for its Vis-Min run. 188 students from 59 schools all over the country tackled various issues related to the theme, and had as outputs, resolutions and action plans. PACU-COA Accreditation

The PACU-COA Level III accreditation visit for the four-year A.B. Humanities program, the terminal for accreditation, took place on March 1-3, 2006. The four criteria chosen to be the object of the visit are instruction, community outreach, faculty and staff development, and library.

We are awaiting the rating status and the Chairman's Report. If the result is positive, future Level III revisits will take place every five years. We will also apply for Level III for the four graduate programs-Master of Science in Industrial Economics, Master in Business Economics, Master in Applied Business Economics and Master of Arts in Education. Level I visit of the seven other graduate programs is being scheduled in School Year 2006-2007.

Philippine Education Network Conference

Established in September 1997, the Philippine Education Network (PEN) is UA&P's educational outreach program to other colleges and universities in the different regions of the country. PEN carries on the tradition of being at the service of the broader academic community, and working with other educational institutions of the country in programs of common interest, especially those to which UA&P is

deeply committed. It addresses the need for educators and administrators to work, study, and engage each other in an atmosphere of friendship and respect.

In order to sustain academic interest in the socially vital link between education and citizenship, the 2005 PEN Conference focused on liberal education and poverty alleviation. The theme was "Liberal Education and Poverty Alleviation: Where is the Connection?" Aside from the issue of liberal education's often obscured meaning, also at issue was the contrast frequently drawn between liberal education, on the one hand, and professional, technical and/or skills education, on the other. Is this distinction a useful one? What role, if any, can liberal education play in alleviating societal poverty, for instance? Should liberal education be distinguished by lack of material, vocational, or economic utility? The Conference was held in Batangas City on September 9-10 for Luzon participants and in Iloilo City on September 23-24 for the Visayas-Mindanao group.

Desk of the Office of Student Affairs also conducted a one-day reading promotion for 100 grade school students in Wawa Elementary School in Batangas with the help of Museo Pambata. It also held its Second Citizenship Challenge, this time engaging high school students in problem analysis and solution crafting in its Project Design Competition. Fourteen schools from Mandaluyong and Pasig City participated, presenting community-based problems ranging from environmental (e.g., mosquito infestation) to social (e.g., vices), and proposed corresponding solutions.

Activities for the Alumni

The Alumni Affairs Office (AAO) continues to reach out to the graduates of the University. In the last school year, it co-organized retreats and a parenting seminar.

In the middle of the school year, its management was transferred to a new set of officers for greater synergy. As a result, almost 700 alumni profiles out of around 4,000 graduates were updated, the office was able to establish a better partnership with the Graduate Schools and Institutes in reaching the alumni, and an alumni ID was launched and released.

A database system is currently being tested by the MIS. Units can update alumni information through a desktop program: alumni can update through the website by October 2007.

CAMPUS DEVELOPMENT

A number of major building and facilities improvements were undertaken in SY 2005-06. The office spaces in the





ALB Building as well as the 2nd, 3rd, and 5th floor landings were renovated. Other areas renovated were the cafeteria kitchen and dining area and the Executive Lounge. Other major improvement projects were the waterproofing of several areas, replacement of air-con units and the construction of a sewage treatment plant in compliance with the "Clean Water Act." The capital expenses for physical facilities amounted to approximately P17.2 million.

In terms of IT equipment, the University augmented various server-side systems including three new servers, a new campus network core switch, a comprehensive tape backup drive system, and a WiFi hospitality base to service the students' wireless Internet access needs by July 2006. Also, 45 new personal computer workstations and seven monochrome laser printers were procured for various departments. The capital expenses for these equipment totaled approximately P5 million.






